## Fish & Game Code

Violations listed below are cited like a traffic violation, but cannot be checked as correctable. If citing into the San Bernardino Main Court, many of these can be direct filed.

7145(a) – Fishing without a license. This section applies to all reptiles (except rattlesnakes), amphibians, & mollusks. (infraction)

## Section 1052 applies to hunting & fishing

1052(a) Transfer any license, tag, stamp, permit, application (misdemeanor)

1052(b) Use or possess any license, tag ...not lawfully issued to the user (misdemeanor)

1052(c) Use or possess any fake or counterfeit license, tag, stamp, permit (misdemeanor)

## Hunting

1054.2 - Hunting without a License (misdemeanor)

2004 - Causing Property Damage/Injuring Livestock while hunting (misdemeanor)

2006 - Loaded Weapon in Vehicle. Fish & Game code allows rounds in the magazine not in the chamber (misdemeanor)

2009 - Interfere with lawful activity of hunting, trapping, or fishing (infraction)

2016 - Hunting in cultivated, fenced, or land posted "No Trespassing." Signs must be posted at least 3 per mile. (misdemeanor)

2017 - Hunting on Land Posted "NO HUNTING" (misdemeanor)

2018 - Destroying posted signs (misdemeanor)

3000 - Take game during hours of darkness (misdemeanor)

3001 - Take game while intoxicated (misdemeanor)

3002 - Shooting Game from Vehicle (misdemeanor)

3004 - Shoot within 150 yds of building (misdemeanor)

3005 - Take bird/mammal with net (misdemeanor)

4341 Any person legally killing a deer in this state shall have the tag countersigned by a person employed in the department... or by a notary public, postmaster, postmistress, **peace officer**, or an officer authorized to administer oaths, before transporting such deer

## Penal Code

PC 12034(a) Driver Allows F&G 2006 Violation

PC 12034(b) Driver Allows Discharge of Weapon

12026.2. (a) Section 12025 does not apply to, or affect, any of the following:

- (3) The transportation of a firearm by a participant when going directly to, or coming directly from, a recognized safety or hunter safety class, or a recognized sporting event involving that firearm.
- (g) Licensed hunters or fishermen carrying pistols, revolvers, or other firearms capable of being concealed upon the person while engaged in hunting or fishing, or transporting those firearms unloaded when going to or returning from the hunting or fishing expedition.

12040. (a) A person commits criminal possession of a firearm when he or she carries a firearm in a public place or on any public street while masked so as to hide his or her identity.

(c) Subdivision (a) shall not apply to the following:

- (5) The possession of a firearm by a licensed hunter while actually engaged in lawful hunting, or while going directly to or returning directly from the hunting expedition.
